In view of Formal Recognition Orders granted by NCTE Bangalore and in pursuance of the orders issued by the Govt., vide G.O.1<sup>st</sup> to 4<sup>th</sup> read above, the Commissioner and Director of School Education, A.P., Hyderabad is pleased to accord **affiliation** in respect of **Rajalaxmi Institute of Elementary Teacher Education, Sarajapattana (V), Tirupathi, Chittoor District** for running D.El., course with an intake of 50 students for the years **2014-15-2017-18** subject to fulfillment of the following conditions:

- 1) The Educational society shall abide by the Instructions/Rules issued by the Government vide G.O. Ms No. 63 School Education, dated: 28-10-2013 read with G.O. Ms. No. 22 School Education, dated: 29-5-2014 and latest NCERT norms.
- 2) The Institution shall adopt the curriculum and syllabus prescribed by the Government of Andhra Pradesh and comply with the norms and standards as prescribed by the NCTE Rules and Regulations and norms.
- 3) The management should not admit students more than intake capacity as per NCTE formal recognition orders.
- 4) The approved staff by the Director, SCERT should be positioned in the entire academic year. If any staff member(s) left the college with any reasons, the vacant post should be filled within a month duly following the procedure.
- 5) The records/accounts shall be furnished to the Director, SCERT A.P., Hyderabad who is the Member-Convenor of the Affiliation Committee every year by 31<sup>st</sup> March of that year for grant of next year affiliation.
- 6) If any changes in name of the society and members of the Governing Body of the Society of the concerned college should be informed to the State Government and SRC, NCTE, Bangalore without any delay.
- 7) If there is any change of address of the college / institution, the management shall be permission SRC, NCTE, Bangalore duly paying prescribed fee to the NCTE and the same should be informed to this office.
- 8) Every institution should obtain NOC from concerned Department to avoid fee defaults.
- 9) Labs, Library and Instructional facilities should be updated as per the latest NCTE norms and standards-2014.

- 10) The institution should not organise Educational Tours to the students without permission of the concerned authorities.
- 11) Admissions in management quota seats in non-minority / minority institutions should follow the rules laid down in G.O. Ms. No. 63 School Edn, dated-28-10-2013 readwith G.O. Ms. No.22 School Edn, dated- 25-5-2014 and do not make any spot admissions in left over / non-reporting seats of Convener-Quota. If any deviations made by institutions, such institutions will put in black list.
- 12) Surprise visits will be conducted by this office to the affiliated colleges without any prior notice. If any deviations / discrepancies noticed, the affiliation will be withdrawn and the same will be informed to the NCTE, Bangalore for withdrawal of recognition.
- 13) Every institution should update their institution in all aspects as per the NCTE Regulations, 2014.

The affiliation now granted is liable for withdrawal by the competent authority and when it is noticed for violating the rules/instructions of NCTE/State Govt., if any, issued by the from time to time.

The Secretary / Correspondent of the *Kapaleswara Institute of Elementary Teacher Education, Bairagipatthar (V), Tirupathi, Chittoor District* is requested to submit a proposal in the prescribed proforma along with valid documents on or before 31<sup>st</sup> of May of every year, as as to enable this office to forward the name of their college to the Convener, DESCET for online web counseling of that particular year.

If any of the management fails to submit their proposal in prescribed proforma in time, the name of the college cannot placed in the online web counseling for that particular.

**ORDER**

**WHEREAS** in terms of Section 14(1) of the NCTE Act, Siddhartha Educational Academy, Plot No. 19-B-150, Rayalaseema Nagar, Bairagipattada Village, Tirupati Head Post Office, Tirupati City and Taluk, Chittoor District - 517501, Andhra Pradesh had submitted an on-line application to the Southern Regional Committee of NCTE on 28.08.2011 and physical application on 05.10.2011 for grant of recognition for D.El.Ed course of two year duration with an annual intake of 50 students at Rayalaseema Institute of Elementary Teacher Education, Khasara No.28, Plot No. 100, Bairagipattada Village, Tirupati Head Post Office, Tirupati City and Taluk, Chittoor District - 517501, Andhra Pradesh.

**AND WHEREAS** on scrutiny of the application submitted by the institution, the documents attached therewith the affidavit and the input received from the visiting team in the form of report and videography, the committee is satisfied that the institution fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratories etc., for running the programme and has appointed duly qualified teaching staff as per NCTE norms.

**NOW, THEREFORE**, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Southern Regional Committee, NCTE hereby grants recognition to Rayalaseema Institute of Elementary Teacher Education, Khasara No.28, Plot No. 100, Bairagipattada Village, Tirupati Head Post Office, Tirupati City and Taluk, Chittoor District - 517501, Andhra Pradesh for conducting D.El.Ed Course of two year duration with an annual intake of 50 students from the academic session 2012-2013 under clause 7(1) of NCTE (Recognition Norms & Procedure) Regulations, 2009 subject to fulfillment of the following conditions:

- i. The endowment fund of Rs.5 lakhs and reserve fund of Rs.3 lakhs kept in joint account with SRC, NCTE should be maintained always. Loan taking or mortgaging of FDRs shall not be done.
  - ii. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
  - iii. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(1) of the NCTE (Recognition Norms & Procedure) Regulations, 2009.
  - iv. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
2. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc. as applicable.

3. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
4. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure -
  - a) Sanctioned programmes along with annual intake in the institution;
  - b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph;
  - c) Name of faculty members who left or joined during the last quarter;
  - d) Names of students admitted during the current session along with qualification, percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
  - e) Fee charged from students;
  - f) Available infrastructural facilities;
  - g) Facilities added during the last quarter;
  - h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
  - i) The institution shall be free to post additional relevant information, if it so seems;
  - j) Any wrong or incomplete information on website shall render the institution liable for withdrawal of recognition.
5. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
